- 11. Security Interest. Title to and a security interest in any works consigned or proceeds of sale under this Agreement are reserved to the Photographer. In the event of any default by the Gallery, the Photographer shall have all the rights of a secured party under the Uniform Commercial Code and the works shall not be subject to claims by the Gallery's creditors. The Gallery agrees to execute and deliver to the Photographer, in the form requested by the Photographer, a financing statement and such other documents which the Photographer may require to protect its security interest in the works.
- 12. Assignment. This Agreement shall not be assignable by either party hereto, provided, however, that the Photographer shall have the right to assign money due him or her hereunder.
- 13. Modifications. All modifications of this Agreement must be in writing and signed by both parties. This Agreement constitutes the entire understanding between the parties hereto.
- 14. Governing Law. This Agreement shall be governed by the laws of the State of New Jersey.
